 - Arbitration proceedings provide you a <u>FAIR HEARING</u>, BUT the arbitration procedures are <u>SIMPLER AND MORE LIMITED</u> THAN RULES APPLICABLE IN COURT.
 - Arbitration decisions are as enforceable as any court order and are subject to <u>VERY</u> LIMITED REVIEW BY A COURT.
 - ARBITRATORS can award the same REMEDIES including DAMAGES that a COURT can award.
 - Any ARBITRATION under these Official Rules <u>WILL BE ON AN INDIVIDUAL BASIS</u>. You understand and agree that <u>YOU ARE WAIVING THE RIGHT TO PARTICIPATE AS A CLASS REPRESENTATIVE OR CLASS MEMBER IN A CLASS ACTION</u>.
 - The PLACE OF ARBITRATION shall be in the federal district WHERE YOU RESIDE.
 - WE WILL REIMBURSE YOU FOR ANY FILING, ADMINISTRATION, AND ARBITRATOR FEES as imposed by the American Arbitration Association. However, if the arbitrator determines that YOUR CLAIM IS **FRIVOLOUS**, **UNWARRANTED**, **OR BROUGHT FOR AN IMPROPER PURPOSE** (in

- accordance with the Federal Rules of Civil Procedure Section 11(b)) YOU WILL RETURN TO US ANY FILING, ADMINISTRATION, AND ARBITRATOR FEES WE PAID.
- If YOU PREVAIL on the merits of your claim in arbitration, WE WILL PAY YOUR ATTORNEYS' FEES. You will NOT be required to pay OUR ATTORNEYS' FEES IF WE PREVAIL.
