Kinecta "We'll pay the interest on your loan" Sweepstakes 2015

Qualifying participants will receive a maximum of one (1) sweepstakes entry during the Sweepstakes period. Handwritten entries must be received at the Credit Union by February 28, 2015 at midnight PST to be eligible for the drawing. The winner will be notified by phone, email (if applicable) and by mail.
- 4. Prize: The prizes will consist of a one-time (1) waiver of interest up to two thousand and fifteen dollars (\$2,015.00) on a Kinecta refinanced auto loan. This will be determined by the winners' terms and conditions of the refinanced auto loan with Kinecta. If a mailed in entry wins the prize Kinecta will cut a check for the total prize amount of two thousand and fifteen dollars (\$2,015.00). The winner will be notified by phone and /or email. Odds of winning are approximately 1 in 1,000 for the prize drawings, however actual odds of winning depend on the number of eligible entries received.
