## **Kinecta Federal Credit Union** Kinecta "Home Equity Line of Credit Draw" Sweepstakes 2015

The winner of the drawing will be announced following the drawing period on or around August 15, 2015. Handwritten entries must be received at the Credit Union by July 31, 2015 at midnight PST to be eligible for the drawing. The winner will be notified by phone, email (if applicable) and by mail.

3. Prize: The prize for each winner will consist of two (2) \$250.00 Kinecta gift cards, with a total value of \$500.00. The winner will be notified by phone and /or email. Odds of winning are approximately 1 in 500 for the prize drawings, however actual odds of winning depend on the number of eligible entries received. Winner cannot substitute, assign, or transfer the prize, except at the sole discretion of the Credit Union. The winner will have 10 business days to respond to Kinecta in order to claim their prize.
